**3. Paddock Access**

Paddock Access will be from 18.00 on Friday and the paddock must be vacated by 20.00 on the Sunday

**4. Competitor Passes**

6 passes are enclosed. Extra passes must be purchased on the gate on arrival at the circuit.

**5. Sign – On**

**Competitors Sign - On**

Competitors will sign - on in Race Administration in the main paddock opposite the scrutineering bay from 6.00pm til 7.00pm on Friday the 4<sup>th</sup> August, & from 7.15am on Saturday the 5<sup>th</sup> August 2017. Any driver that has not signed – on by 10.00am may be deemed as a non starter.

Competitors must provide a valid MSA Competition licence and a current club membership card at sign – on. Entrants must also provide a valid MSA Entrants Licence.

Competitors with non – MSA Licences are reminded that they must produce the written approval of their ASN that they may compete in the meeting. Competitors are reminded that licences and upgrade cards must be valid bearing a recent photograph and be signed by the competitor.

**6. Scrutineering**

Scrutineering will take place from 7.15am on Saturday 5<sup>th</sup> August once the competitor has signed – on.

Eligibility may be checked by the appointed eligibility scrutineer.

**7. Notice Board**

The official notice board is located in race administration where the results etc. will be displayed.

**8. Drivers Briefing**

The mandatory driver briefings will take place at the scrutineering bay at 8.40am (Saturday) 8.30am (Sunday) For Sunday drivers only.

Further briefings which will be announced may be called at the discretion of the Clerk of the Course.

**9. Noise Pollution**

Engines must not be run before 8.45am or after 18.15pm on either day.

**10. Re – Fuelling**

There is a mandatory refuelling area situated in the Pit Lane Area.

11. **Circuit Access & Egress**  
Please assemble in the designated assembly area. For practice you will be signalled to go directly out onto the circuit. For the race you will be signalled to go out onto the circuit to form on the grid. The white lines on the circuit edge delineate the track width, which is normally usable, Any driver reported for exceeding track limits to the clerk of the course whether any advantage is gained or not may be subject to a penalty as laid down in the blue book.
12. **Live Snatch**  
No "live snatch" will be undertaken at this meeting.
13. **Red Flags**  
In the case of a race stoppage drivers should slowly return to the grid and/or follow the directions given by the marshals & Parc Ferme rules apply. The race will be re-run immediately so the onus is on the competitor to ensure there is sufficient fuel in the car.
14. **Results**  
All time sheets, grids and results are deemed to be provisional until the conclusion of all judicial actions.
15. **Presentations**  
The presentations for all categories will take place in the F1 Bar and/or The Winner's Podium.
16. **Judges of Fact**  
Judges of Fact may be appointed in accordance with G10 and Q18 of the current MSA Yearbook.
17. **Race Day Information**  
The organisers will try to run the programme as published however reserve the right to bring forward, delay or abandon event sessions to suit the conditions.
18. **Video Equipment**  
Video equipment may be fitted to the car if it is not used for commercial purposes. All equipment must be fitted to the vehicle at scrutineering and failure to do so may mean that the camera will be removed.
19. **Circuit & Meeting Notes**  
BARC will not be liable for any damage caused to vehicles being recovered from the track.  
Competitors who experience mechanical problems, particularly if that problem is likely to be a hazard to others, must be stopped immediately in a place of safety. The competitor may also be liable for any excessive clean – up costs involved.  
Motorsport is a non – contact sport and competitors who make contact with each other render themselves liable to penalties in accordance with the current MSA Yearbook. Likewise competitors should remain within the white lines defining the edges of the circuit. Failure to do so will render the competitor liable to penalties up to and including exclusion.  
No fuel is available for sale at the circuit.  
All working areas should be kept clean and tidy and any waste placed in the appropriate container. Waste must not be mixed or left around the site. In the event that the BARC is charged for such issues then the charge will be passed on to the championship concerned if the individual cannot be identified.  
Any person who is injured or feels unwell should seek help from the circuit medical services. Please contact an official member of the venue management team.
20. **Marshals Matters**  
Entry into this event will be by MSA ID Card as with previous events. Anybody who has not got an ID Card, please contact the circuit office on tel: 01554891042 so arrangements can be made for your tickets to be left on the main gate.  
Post allocations will be advised at sign-on.
